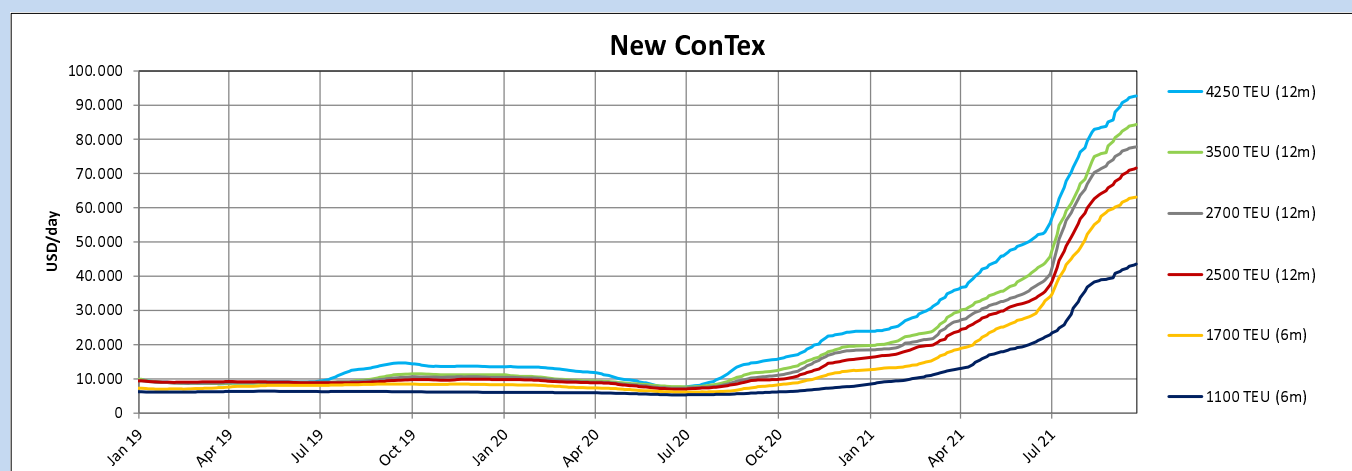

New ConTex-Commentary - issued:		23.09.21
Looking at the actual activity within the chartering market, the weeks past by rather uneventful. However this is not a sign of any weakening, the sentiment is still positive, but since there are hardly any vessels available on the market, the number of transactions is limited. Time charter rates are stable on the rise on so the ConTex is consequently increasing alike and is closing at 3170 points. All segments are registering positive increases, but this week the small feeder segment showed the best improvement. The 1100 TEU increased by USD 730 basis the 6 months period, i.e. gaining 1,7% compared to year on year figures this segment is showing a hefty rise of about 610%. The 1700 TEU is even registering an increase of 683,3% year on year. 4250's closing at USD 92.690 this week, moderate increase of USD 530.
