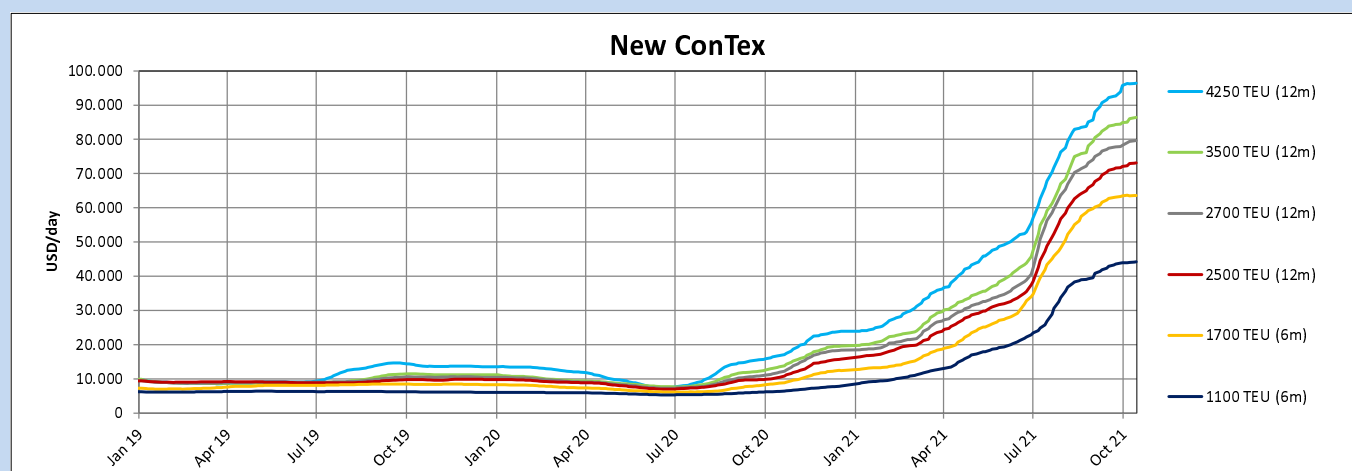

New ConTex-Commentary - issued:		14.10.21
With the last week holiday season in Far East the new week did not offer big changes on the container side. The New ConTex remain on a sideways movement with rate levels being stable and marginal & small upwards trend. Still the number of available vessels remains so limited that only few deals are reported. The timecharter rates in any segment are extremely healthy compared on the year to year basis and there are no real signs that the problems like on production/logistic chain combined with the port congestion and delayed delivered goods will be solved within short time. On weekly basis we see and can read the problems which come up now like the car factories are limiting or closing down their productions. Even the MPP vessels suitable to carry containers are still needed and being pushed into the container segment and some have been fixed for some liner trades already. All in all the outlook is positive for all container segments.
