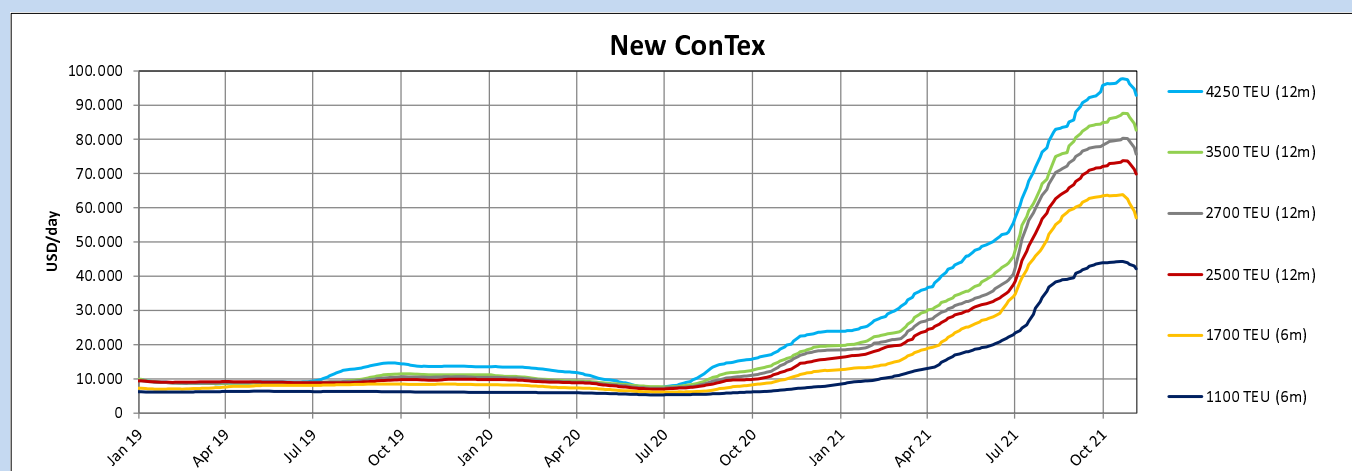

New ConTex-Commentary - issued:		04.11.21
After the New ConTex curve started flattening a couple of weeks ago, we again saw an overall decrease this week. The w-o-w downturns ranging from a bit over 1% in the large segments to as high as over 7% for the 1700 TEU vessels for short-term business. As there is still active demand for tonnage in the market, we do agree that this downturn (which may continue a few weeks) is merely an adjustment of the previously overheated market and that we are only coming back to more reasonable levels, still healthy enough for both Owners and Charterers and probably also sufficient to get over the the coming holiday season, since there are still periods being fixed Owners would have dreamed about a year and a half ago at rates in average 3.5 times of those in the y-o-y comparison.
