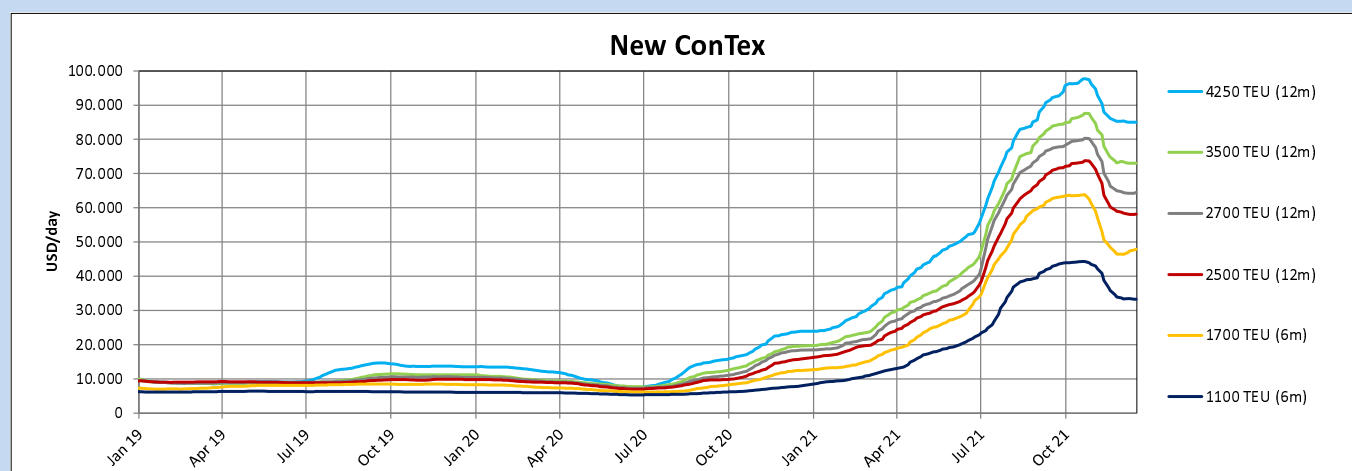

New ConTex-Commentary - issued:		16.12.21
"Tis the season to be jolly" and although the market has plateaued recently, there is still plenty to be cheerful about. The New ConTex sits at 2613 points. While this is only a modest 0.2% change from last week, it is unbelievable to see the year-on-year percentage increase at a staggering 272.2%. This week, the rates for 2,700 have risen by 1.1% to \$46,218 for 24 months, while the 1,700 segment has also climbed by 0.7% to \$42,683 for 12 months. Inevitably, fixing activity will slow over the next few weeks, however given the limited number of positions coming open, owners bargaining power should remain robust as we head into the new year.
