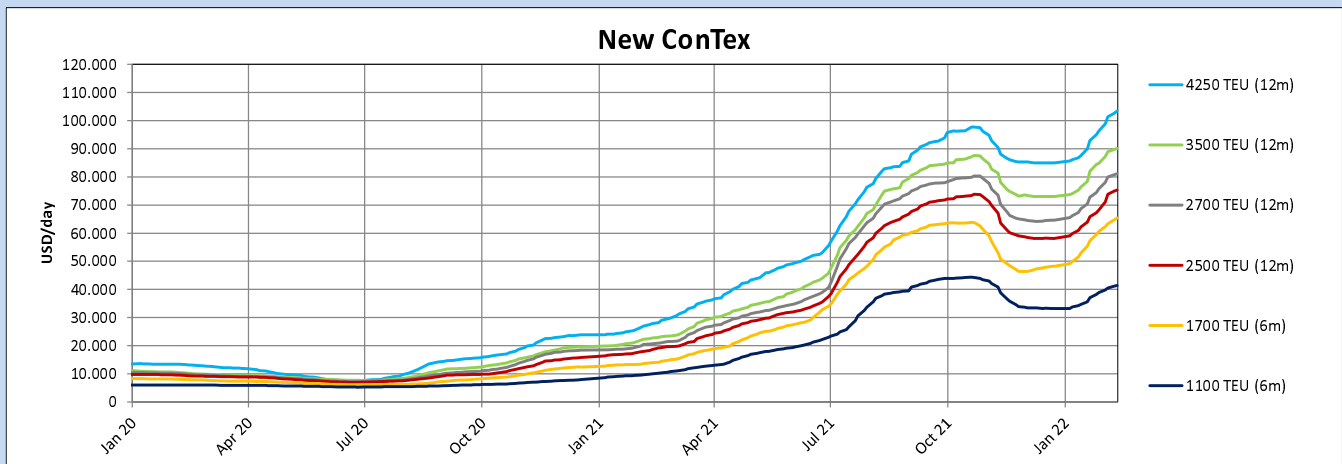

New ConTex-Commentary - issued:	10.02.22
<p>This week saw the end of the holidays in Asia, which had a damping effect on the overall activity. However, even with the decline in activity the New ConTex development continues to point upwards with new historic levels being reached again this week. February is up 21.7% from January and over 300% from February 2021, underlining how extraordinary this market really is. With lack of supply in the larger segments, the 1100TEU and especially the 1700TEU are seeing the most traction and therefore the biggest jumps in charter rates. Same time last year 1700TEU New ConTex was at USD 14,000 compared to USD 50k+ this week, although recent fixtures in 2022 have been even at higher levels. The 2500-3500TEU segments are seeing steady upward trends mostly logically adjusted to account for what is being recorded for the smaller sized tonnage. However, with availability of supply in the 2500-4250TEU approaching in spring there will likely be an effect on the New ConTex trends accordingly. With close to zero vessels available in 2022 for the 5700TEU and 6500TEU segments, these trends will continue to be logical adjustments if the overall trend and activity escalate further.</p>
