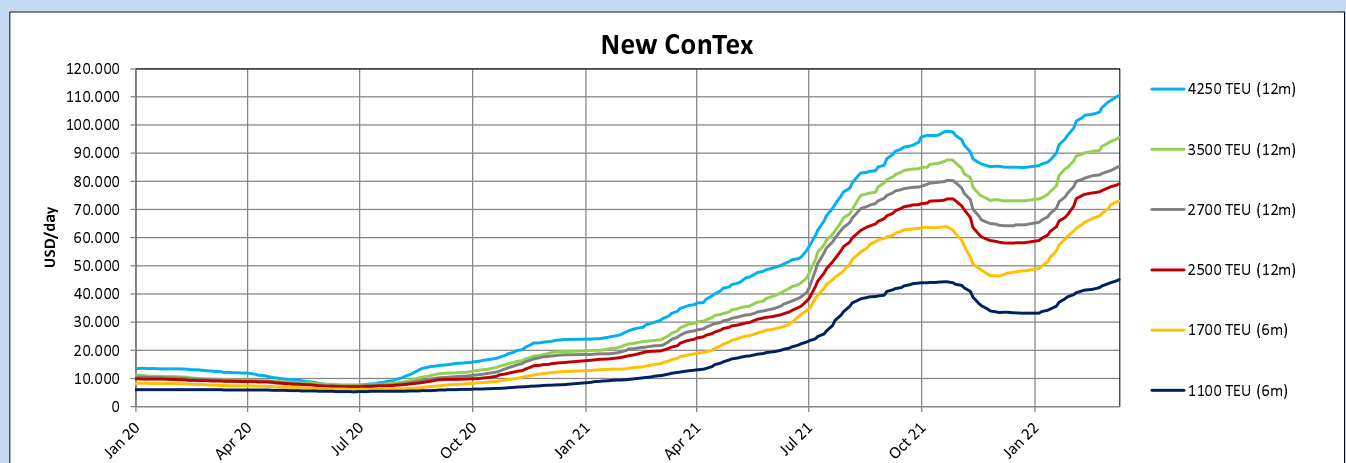

New ConTex-Commentary - issued:		10.03.22
Despite the situation in Ukraine, the New ConTex increased this week by 1.8% to 3551 points. The 1,100TEU segment had the biggest jump in charter hire rates, with the 12 month figure increasing by 2.6% to USD 40,567. Tonnage above 2,500TEU remains incredibly tight, with the New ConTex adjusted accordingly in order to account for what is being recorded in the smaller sizes. The growing impact of sanctions against Russian related cargoes & VLSFO prices hitting record breaking levels of USD 1,000 per ton has become an issue for carriers. This combined with the SCFI figures decreasing for the eighth week consecutively, could eventually lessen desire for container tonnage, worldwide. For now though, there is still a strong demand for all sizes of ships with the New ConTex continuing to reach all-time highs.
